LTA relinquished by OPGCL w.e.f 13.12.2018. OPGCL is evacuating its power through intrastate transmission system of Odisha and presently, there is no existing LTA or MTOA with ISTS, hence, no LTA/MTOA/STOA regulation could be implemented by NLDC/RLDCs.
