Ayana already made back to back payments to APSPCPL, hence, Regulation of access is limited only to Ayana by NLDC/RLDCs].
2	Odisha Power Generation Corporation Ltd	17.04	473 Days	The said dues pertains to mismatch period for the POWERGRID Bays at Jharsuguda for 400 KV D/C OPGCL - Jharsuguda TL and also tr.charges of 400 KV D/C OPGCL - Jharsuguda TL of OGPTL. LTA relinquished by OPGCL w.e.f 13.12.2018. OPGCL is evacuating its power through intrastate transmission system of Odisha and presently, there is no existing LTA or MTOA with ISTS, hence, no LTA/MTOA/STOA regulation could be implemented by NLDC/RLDCs.  Further, in an Appeal No.16 of 2020 filed by OPGCL against the levy of transmission charges for mismatch period, Hon'ble APTEL restrained CTU from encashing the Bank Guarantee submitted by OPGCL until disposal of the Appeal No. 322 of 2019. Last hearing was held on 21.04.2023. Matter is being pursued.
