1	AP Solar Power Corporation Pvt Ltd	11.76	444 Days	<p>APSPCPL is solar power park developer wherein several solar power developers (SPDs) incl. Ayana Ananthapuram Solar Pvt Ltd setup their generation. The dues pertains to APSPCPL towards transmission charges for mismatch period for delay in COD of their generation. When regulation was imposed on APSPCPL. M/s Ayana Ananthapuram Solar Pvt Ltd filed a WP no. 39872 of 2022 in AP High Court against any coercive measures, wherein Hon'ble AP High Court granted stay vide Order dtd 09.12.2022 and thereafter the stay is being extended from time to time. Last hearing held on 08.12.2023 and the next date of hearing is yet to be notified.</p> <p>[It is learnt from APSPCPL that, the SPDs excl. Ayana already made back to back payments to APSPCPL, hence, Regulation of access is limited only to Ayana by NLDC/RLDCs].</p>
2	Odisha Power Generation Corporation Ltd	17.04	388 Days	<p>The said dues pertains to mismatch period for the POWERGRID Bays at Jharsuguda for 400 KV D/C OPGCL - Jharsuguda TL and also tr.charges of 400 KV D/C OPGCL - Jharsuguda TL of OGPTEL. LTA relinquished by OPGCL w.e.f 13.12.2018. OPGCL is evacuating its power through intrastate transmission system of Odisha and presently, there is no existing LTA or MTOA with ISTS, hence, no LTA/MTOA/STOA regulation could be implemented by NLDC/RLDCs.</p> <p>Further, in an Appeal No.16 of 2020 filed by OPGCL against the levy of transmission charges for mismatch period, Hon'ble APTEL restrained CTU from encashing the Bank Guarantee submitted by OPGCL until disposal of the Appeal No. 322 of 2019. Last hearing was held on 21.04.2023. Matter is being pursued.</p>
3	ACME Solar Holdings Pvt. Ltd.-Fatehgarh	8.80	45 Days	Hon'ble APTEL vide orders dated 14.12.2023 in Appeal No. 260 of 2022 & 261 of 2022 vacated the stay.
